#### New & Revised Hong Kong Financial Reporting Standards

The Hona Kona Institute of Certified Public Accountants ('HKICPA', formerly the Hong Kong Society of Accountants) has issued a number of new and revised Hong Kong Financial Reporting Standards and Hong Kong Accounting Standards ('new HKFRSs'). The new HKFRSs are effective for accounting periods beginning on or after 1 January 2005 and replace the existing Statements of Standard Accounting Practice. In convergence with International Financial Reporting Standards ('IFRSs') pronounced by the International Accounting Standards Board, the new HKFRSs align with the requirements of IFRSs in all material respects and have numbers corresponding to the equivalent IFRSs.

On 26 January 2005, HKICPA also issued a circular recommending the preparers of financial statements to disclose the possible effect of the changes resulting from the subsequent application of new HKFRSs so that the readers of those statements could understand the ramifications of these new HKFRSs.

In light of the above, an understanding of the recently issued accounting standards and their impact on the accounting policies adopted by the reporting entity is essential.

As far as the financial reporting for small and medium-sized entities ('SME') is concerned, HKICPA issued its final proposal in the form of an Exposure Draft on 2 March 2005. It expects that with the completion of the final consultation process by end of April 2005, the final SME financial reporting framework and standard will be issued in June 2005. Accordingly, those companies which are qualified can start using them for financial reporting periods that begin on or after 1 January 2005.

# Hong Kong Budget for 2005/2006

The Financial Secretary, Mr. Henry Tang presented his 2005/06 Budget on 16 March 2005.

Mr. Tang did not introduce any new taxes nor did he raise existing ones. The much talked about Goods and Services Tax has been put back for further public consultation. He proposed two new allowances for Salaries Tax payers. A brief summary of his proposals is as follows:

1. A new allowance for dependent parent or grandparent aged between 55 to 59 will be granted. The basic allowance is HK\$15,000 a year.

An additional allowance of HK\$15,000 will be granted if the taxpayer resides with the dependent.

- 2. Child allowance will be increased from HK\$30,000 to HK\$40,000.
- 3. Mr. Tang proposed the abolition of estate duty. This will help to promote and develop Hong Kong into a premier asset management centre.
- 4. Rate charges on properties will remain at 5%. But the rateable value of properties has increased by 7% on average during the latest revaluation. Hence, it is expected that about 65% of ratepayers will have to pay about HK\$40 more a month.
- 5. The Environment, Transport and Works Bureau is undertaking studies on the introduction of 'Green' taxes on waste tyres and plastic bags, based on the 'polluter pays' principle.

The proposed allowances though inadequate do provide a measure of relieve to some salaries taxpayers. However, the abolition of estate duty should make Hong Kong an attractive centre for asset managment.

# Mainland Enterprises are encouraged to 'branch out'

On 1 October 2004, 'No. 16 pronouncement of 2004' on 'Regulations to Approve Establishment of Enterprises Outside China' was issued in the name of Bo Xilai, the Minister of Commerce. 135 countries and regions were approved for investment, including 38 in Asia, 37 in Europe, 42 in Africa, 14 in North and South America and 4 in Oceania. Except for U.S.A., Singapore, Japan and those countries not having established foreign relations with China, almost all other countries in the world were included on the list.

There is a note placed in front of the list stating 'the Ministry of Commerce mandates the provincial authority in charge of commerce to approve the investment'. That means only the Ministry, not the provincial authority, is authorized to deal with the investment approval in U.S.A., Singapore and Japan, which are not on the list.

The Mainland enterprises are very positive about the pronouncement because they

feel that they are really encouraged to branch out. The feasibility report, which was a must in the past, is now not required. Article 5 in the pronouncement clearly stipulates: 'the enterprise shall be solely responsible for the economic and technical feasibility of the investment'.

It is believed that, based on the pronouncement, enterprises can directly set up entities by purchasing and transferring exchange through relevant authorities. Regarding the establishment of enterprises in Hong Kong and Macao, the Regulations to Approve Establishment of Enterprises in Hong Kong and Macao pronounced on 31 August 2004 still apply. The modes of investment are the same as those in pronouncement No. 16, eq. new establishment (including wholly owned, joint venture and co-operative investment), purchase, merger, capital injection, equity swap, etc.

### HKTDC Guangzhou Forum

The Hong Kong Trade Development Council (HKTDC) held a CEO Forum and Mini-Expo on Hong Kong Services on 20 January 2005 in Guangzhou. Mr. Liang Zhenying hosted the forum and Mr. Chen Qizong, Prof. Liu Zunyi, Mr. Qian Guofeng, CEOs of CLP, Jardine and Jebsen as well as entrepreneurs of famous Mainland entities joined the dialogue. More than 200 quests were present.

Our director, Mr. Eugene Fung gave a speech on 'The Advantages of Mainland

Enterprises setting up companies in Hong Kong'. Eugene's talk was well received. We handed out all our 600 brochures at the seminar.

#### 新修訂之香港財務報 告準則

香港會計師公會(「公會」)已頒佈多項新訂及修訂之香港財務報告準則及香港會計準則(「新香港財務報告準則」),並於2005年1月1日或其後開始之會計年度生效,取代現行之會計實務準則。為了與國際會計準則委員會所頒佈的國際財務報告準則(「IFRSs」)接軌,新香港財務報告準則在所有重大方面都依從IFRSs的要求,而準則編號亦和有關的IFRSs相對應。

公會亦於2005年1月26日發出通告,建議編製財務報表的人士披露由於隨後採用新香港財務報告準則可能引致的後果,使財務報表的讀者能了解此等新香港財務報告準則的影響。

觀乎上述進展,瞭解近期頒佈的會計準則以 及其對報告實體所採用之會計政策的影響是 極其重要的。

就中小型企業財務報告而言,公會於2005年3月2日以徵求意見稿形式發表了最終的建議文件,預期將於2005年6月正式頒佈中小企財務報告總綱及準則。據此,合資格公司將可在2005年1月1日或以後開始的財務報告年度內率先採納。

#### 2005/2006

#### 財政預算案

財政司司長唐英年於2005年3月16日發表 2005/06年度財政預算案。税制方面唐司長 並沒有加入新税種,薪俸税則增加了兩項免 税額。有關唐司長對税制的動議簡述如下:

- 1. 需要供養55至59歲的父母或祖父母的納税人,每年可享有每名受供養者15,000元的免稅額。
- 與父母或祖父母同住的納税人,可額外享有15,000元的免税額。
- 每名子女免税額由30,000元增加至40,000元。
- 4. 為推動和發展香港成為區內資產管理中心,唐司長建議廢除遺產稅。現時遺產稅為政府帶來每年15億元的收入。
- 5. 差餉徵收率將維持在百分之五的水平, 但最新的全面重估顯示,應課差餉租值平均

上升百分之七,因此,約百分之六十五的繳 納差餉人十,下年度每月須多付40元。

6. 環境運輸及工務局現正就廢車胎和膠袋 廢料,研究以「污染者自付」的原則開徵「 環保税」。

該預算案可算審慎,新增的免税額對減輕一般人的稅務負擔則甚為不足;對扶貧方面就更加欠奉。但取消遺產稅卻可增加香港對海外投資者的吸引力,使更多人在香港持有資產,值得推許。

#### 鼓勵內地企業「走出去」



2004年10月1日,中國商務部以部長薄熙來之名發出了2004年第16號文:《關於境外投資開辦企業核准事項的規定》,列出了可前往投資開辦企業的國家和地區共計有135個,包括亞洲38個、歐洲37個、非洲42個、南北美洲14個及大洋洲4個。除了美國、新加坡、日本和一些未有邦交的國家之外,幾乎所有國家都已包括在內。

文中列出國家和地區名稱之前有一句話,說是「商務部委託各省級商務主管部門核准」 企業前往投資的。換言之,未在名單上的如 美國、新加坡及日本需由商務部自行操辦, 省級部門辦不了。

內地企業界對此文件的反應十分正面,並認為是真正鼓勵企業走出去。以前例必要提交的可行性研究文件取消了。文中第五條最後一段說得清楚:「國內企業境外投資開辦企業在經濟、技術上是否可行,由企業自行負責」。

相信依據此文件,企業可通過有關機構購匯 和把外匯匯出,直接開辦境外企業。
